# **Informal Meeting of the SAARC Council of Ministers**

SAARC Council of Ministers met in an informal session in New York on 21 September 2017 on the sidelines of the Seventy-second Session of the United Nations General Assembly.

H. E. Mr. Krishna Bahadur Mahara, Deputy Prime Minister and Foreign Minister of Nepal, presided over the deliberations of the meeting, attended by the Hon. Foreign Ministers of the SAARC Member States. In his opening remarks, he highlighted the important initiatives taken by Nepal, as the Chair of SAARC, in pursuance of the directives of the Eighteenth SAARC Summit held in Kathmandu in November 2014.

H. E. Mr. Amjad Hussain B. Sial, Secretary General of SAARC, in his brief remarks, apprised the Hon. Foreign Ministers of the progress achieved in the implementation of the decisions of the Eighteenth SAARC Summit (Kathmandu, November 2014) and the Thirty-seventh Session of the Council of Ministers (Pokhara, March 2016).

During the meeting, the Hon. Ministers reiterated their full commitment to the SAARC process and stressed the need to promote progress and prosperity of the peoples of the region through the platform of SAARC. In order to enhance economic relations, people-to-people contacts and tourism, the Hon. Ministers emphasised the need to improve connectivity in the region. They commended the work done by the SAARC Secretariat and underlined that it should play even greater role in promoting the objectives of SAARC. They also tasked the SAARC Secretariat to coordinate the dates for the Nineteenth SAARC Summit and its preceding meetings to be hosted by Pakistan.

Addressing the Inaugural Session of the Roundtable, the Secretary General stated, "SAARC is dedicated to strengthening regional cooperation to accelerate the implementation of global and regional commitments related to children. Through its Social Charter, Declarations of the SAARC Summits, Ministerial Statements, Conventions and various related forums, SAARC has continued to give high prominence to its agenda on children. Among others, child nutrition remains an important component of SAARC's endeavour to make South Asia a region, where every child can grow to their full potential in a healthy and safe environment."



Secretary General addresses the International Business Women's Summit

H. E. Mr. Amjad Hussain B. Sial, Secretary General of SAARC, addressed the Inaugural Session of the International Business Women's Summit in Kathmandu on 11 September 2017.

In his address at the Inaugural Session of the Summit, the Secretary General said, "In spite of the general perception that the role of women is confined to household affairs, since the turn of the century, the status of women has been changing rapidly due to growing industrialization and globalization, coupled with conducive social legislations, and international

legal instruments. Moreover, with the changing socio-cultural values and spread of education and awareness, proper exposure and need for additional income, women are increasingly engaged in professional activities, including entrepreneurship. On top of everything, despite challenges, women's perseverance is the cardinal factor in the development of entrepreneurship by women. They have proved that women are also endowed with abundant innate qualities that can make them successful entrepreneurs." He further said, "This Summit is an occasion to commend and rejoice the success stories of entrepreneurial women. This Summit is also an opportunity to dispel the myth that the role of women is confined to household affairs only."



**Secretary General addresses the Workshop on Re-energizing the SAARC Process** 

H. E. Mr. Amjad Hussain B. Sial, Secretary General of SAARC, addressed the Workshop on Re-energizing the SAARC Process on 21 August 2017 held at Singapore.

The Workshop was jointly organized by the Consortium of South Asian Think Tanks (COSATT), Centre for South Asian Studies, Kathmandu, and the Institute of South Asian Studies, Singapore, with the support of Konrad Adenauer Stiftung, Germany.

In his Key-Note address delivered through videoconferencing, the Secretary General said, "... SAARC is a people-centric organization. As enshrined in its Charter, promotion of welfare and wellbeing of the peoples is the cardinal objective of SAARC. It is, therefore, essential that all endeavours in the SAARC process should be geared toward the attainment of this objective."

The Workshop brought together representatives of thinktanks from the SAARC region.

SAARCLAW, an Apex Body of SAARC, commemorated its twenty-fifth anniversary by organizing the Fourteenth SAARCLAW Conference in Colombo on 27 October 2017. The SAARCLAW Conference was followed by the Eleventh SAARC Chief Justices' Conference on 28 and 29 October 2017.

In his Address at the Inaugural Session of the SAARCLAW Conference, H. E. Mr. Amjad Hussain B. Sial, Secretary General of SAARC, stated that, "... Law and order contributes to peace, security, welfare of the peoples, and happiness in our societies. Law and order is equally important for the dispensation of justice to protect people's rights, liberties and freedoms. The legal community has the cardinal role to play in promoting law and order and to address the challenges in this regard. SAARCLAW provides a useful regional platform to collectively reflect on the challenges and opportunities within its domain."

The Secretary General also launched during the Inaugural Session a book entitled "SAARC and SAARCLAW."

Fourth Meeting of SAARC Expert Group on Renewable Energy

The Fourth Meeting of the SAARC Expert Group on Renewable Energy was held on 12-13 September 2017 in Islamabad.

The Group approved the creation of a "Revolving Fund" for the promotion of renewable energy in the SAARC region. The Fund would be utilized for renewable energy projects within the SAARC region (solar, wind, geothermal, small hydropower, biogas/biomass and hybrid) upto a maximum capacity of 2MW in each country. The Group also adopted its Work Plan for the year 2018.

# **Meeting of the Core Group of SAARC Immigration and Visa Experts**

The Meeting of the Core Group of SAARC Immigration and Visa Experts was held on 10 October 2017 at the SAARC Secretariat, Kathmandu.

The Meeting was opened by H. E. Mr. Amjad Hussain B. Sial, Secretary General of SAARC. In his remarks, he underscored that the SAARC Visa Exemption Scheme (SVES) was an important step taken by the SAARC leaders towards enhancing people-to-people contacts in the region. While referring to the SAARC Motor Vehicles, SAARC Railways and SAARC Air Services Agreements, the Secretary General stated that the people will be able to benefit from these Agreements through conducive visa and immigration regimes, and improved infrastructure. He further stated that this will also help in making speedy progress towards the ultimate goal of the South Asian Economic Union, as envisioned by our Leaders during the Eighteenth SAARC Summit.



The Meeting approved the Request for Proposals (RFPs), prepared by the Secretariat, for development of security software for SVES.

Second Meeting of the SAARC Council of Experts of Energy Regulators (Electricity)

The Second Meeting of the SAARC Council of Experts of Energy Regulators (Electricity) was held on 24-25 October 2017 in Islamabad. The Meeting was organized with the technical and financial support of the Asian Development Bank.

The Meeting was attended by the representatives of the Member States of SAARC and its international partners (ADB and SARI/EI). The Meeting discussed the draft roadmap, prepared by the SAARC Secretariat, for the implementation of the SAARC Framework Agreement on Energy Cooperation (Electricity).



Second SAARC-ADB Workshop of the Inter Governmental Expert Group on Ĉlimate Change

The Second SAARC-ADB Workshop of the Inter-Governmental Expert Group on Climate Change to finalize the Study on "Climate Risks in the Region: Ways to Address Social, Embassy of India in Kathiliandu.

Economic and Environmental Challenges" was held in Wajih-ul-Hussain A. Sial and Fehmida A. Sial from the SAARC Colombo on 16-17 October 2017.

The Workshop was attended by representatives from all Member States, SAARC Secretariat and ADB, and Consultants. The Study was conducted with the financial and technical assistance of ADB.

## **SAARC Internship Programme**

The SAARC Secretariat offers internship to under-graduate, graduate and post-graduate students from South Asia and researchers of any nationality working in South Asian research institutes based within the region. The overall objective of the programme is to promote awareness about the South Asian Association for Regional Cooperation (SAARC) in and beyond South Asia. Under this programme, interested students or researchers are placed at the SAARC Secretariat in Kathmandu for a period of two weeks to six months, depending on the need and nature of the projected research work. In August 2017, two students successfully completed their internship programme, while two students are undergoing internship at the Secretariat.

JENESYS-2017

The Government of Japan has been offering the Japan-SAARC Network Programme of the People-to-People Exchange (JENESYS) from 2007-08. The Secretariat has signed the Revised Memorandum of Guidelines for implementation of the JENESYS-2017 Youth Exchange Programme on 16 October SAARC Arbitration Council (SARCO) 2017.

Under the Programme, the Government of Japan has allocated JPN 105,397,000 (US\$ 926,974.49@ JPY 113.7/US\$). A total of 240 youths in two batches will visit Japan for a week. Japan International Cooperation Centre (JICE) is the implementing agency for the programme. Economic Cooperation and Connectivity have been chosen as the theme for JENESYS 2. 2017.

**SAARC Friendly Badminton Competition**
